Management Discussion of Fund Performance

Results of Operations

Axiom Global Growth Portfolio (the *Portfolio*) invests in units of various Renaissance Private Pools (individually, an *Underlying Fund* and, collectively, the *Underlying Funds*) which can be found in the Top Positions table of the Summary of Investment Portfolio. The Portfolio's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the six-month period ended February 29, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Portfolio's net asset value decreased by 7% during the period, from \$65,023 as at August 31, 2019 to \$60,728 as at February 29, 2020. Net redemptions of \$5,287 were partially offset by positive investment performance, resulting in an overall decrease in net asset value.

Class A units of the Portfolio posted a return of 1.1% for the period. The Portfolio's primary benchmark, the MSCI World Index (the *primary benchmark*), returned 2.1% for the same period. The Portfolio's blended benchmark (the *blended benchmark*) comprises 29% S&P 500 Index, 21% MSCI EAFE Index, 16% S&P/TSX Composite Index, 10% FTSE World Government Bond Index (Hedged to CAD), 10% FTSE Canada Universe Bond Index, 10% MSCI Emerging Markets Index and 4% S&P/TSX Composite Dividend Index. The blended benchmark returned 1.9% for the same period. The blended benchmark closely reflects the asset classes in which the Portfolio invests, and is designed to provide a more useful comparative to the Portfolio's performance. The Portfolio's return is after the deduction of fees and expenses, unlike the primary and blended benchmarks. See *Past Performance* for the returns of other classes of units offered by the Portfolio.

The Portfolio has a target asset allocation of 29% U.S. equities, 21% international equities, 16% Canadian equities, 10% Canadian fixed income securities, 10% emerging markets equities, 10% global fixed income securities and 4% Canadian income-generating investments.

Recession concerns abated late in 2019 as economic growth improved and investors anticipated a reduction in trade frictions between the U.S. and China. However, global recession concerns resurfaced in late February 2020 as COVID-19 disrupted supply chains between China and the rest of the world. The uncertain environment boosted the U.S. dollar, causing most currencies to weaken against it. The U.S. Federal Reserve Board continued to lower interest rates and resumed buying securities. This signalled to investors that it was ready to ensure sufficient liquidity in financial markets.

The U.S. equity market was resilient until the end of the period, with overall gains in the second half of 2019. High-valuation growth stocks, particularly in the information technology sector, led the market higher in 2019. U.S. equities started 2020 with generally positive returns. However, equities sold off sharply in February. The COVID-19 outbreak weakened demand across the travel and tourism industry, and caused disruptions in global supply chains. There were increasing concerns that the virus could turn into a global pandemic.

In international markets, several central banks stepped in with pre-emptive strikes against potential COVID-19 fallout. The British pound rebounded strongly, and "safe haven" currencies, such as the Swiss franc, performed well against the Canadian dollar, particularly in January and February amid heightened market volatility. Commodity-linked and emerging markets currencies underperformed, driven by heightened volatility and declining commodity prices.

International equity markets experienced significant volatility during the period amid global economic concerns and the outbreak of COVID-19. Stocks rebounded decisively in the fourth quarter of 2019 on encouraging earnings reports, anticipation of a U.S.-China trade deal and improved prospects for an orderly exit for the U.K. from the European Union (*EU*). They then declined sharply in February as concerns of the potential economic impact of a widening COVID-19 outbreak weighed on investor confidence.

The Canadian equity market, including income-generating investments, had positive returns during the fourth quarter of 2019 in

response to an improving macroeconomic backdrop. This ended a solid year, with 2019 marking the strongest annual return in Canada since 2009. The positive market sentiment and returns continued as 2020 began until the COVID-19 outbreak. With the rise of cases in the last week of February, COVID-19 concerns intensified and investors were considering a prolonged impact on global economic growth. The Canadian equity market declined, with energy producers and base metals companies being among the most affected as China's economy makes up a large portion of demand for numerous commodities.

Canadian fixed income assets posted positive returns, with riskier assets generally outperforming. Canadian provincial bonds outperformed their federal counterparts, but both underperformed relative to Canadian corporate bonds. Canada's inflation rate held firm at close to the Bank of Canada's 2% target.

In emerging markets, the U.S. and China signed a "phase one" trade agreement in January, to which investors responded positively. However, the outbreak of COVID-19 subsequently led to a sharp decline across emerging market equities.

In terms of global fixed income, higher-quality developed market bonds rebounded amid the uncertainty surrounding COVID-19, while many emerging markets bond markets and currencies declined, given their close links to Chinese economic growth and export demand.

Renaissance U.S. Equity Private Pool was the most significant detractor from the Portfolio's performance relative to the blended benchmark, followed by Renaissance Canadian Equity Private Pool and Renaissance Global Bond Private Pool.

Renaissance International Equity Private Pool was the most significant contributor to the Portfolio's performance relative to the blended benchmark, followed by Renaissance Emerging Markets Equity Private Pool and Renaissance Canadian Fixed Income Private Pool.

Recent Developments

The composition of the Independent Review Committee (*IRC*) changed. Don Hunter and Merle Kriss retired effective April 26, 2020. David Forster and Deborah Leckman were appointed as members of the IRC effective April 27, 2020.

The outbreak of COVID-19 (the disease caused by a new coronavirus) in China in December 2019, and its subsequent spread and designation as a global pandemic, has caused a slowdown in global economic activity and sustained market volatility. This has impacted global markets, with the most significant valuation changes occurring since the end of the review period. This has affected, or could affect, the performance of the Portfolio in an adverse manner.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Portfolio, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Portfolio

CAMI, a wholly-owned subsidiary of CIBC, is the Portfolio's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Portfolio's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Portfolio as described in *Management Fees*. As Trustee, CAMI holds title to the Portfolio's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Portfolio. CAMI also compensates dealers in connection with their marketing activities regarding the Portfolio. From time to time, CAMI may invest in units of the Portfolio.

Distributor

Dealers and other firms sell units of the Portfolio to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Portfolio. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Portfolio to investors.

Portfolio Transactions

The Portfolio may undertake currency and currency derivative transactions where CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC is the counterparty (the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Portfolio (the *Custodian*). The Custodian holds all cash and securities for the Portfolio and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Portfolio including record-keeping and processing foreign exchange transactions. The fees and spreads for services of the Custodian are paid by CAMI and charged to the Portfolio on a recoverable basis. CIBC owns a 50% interest in the Custodian.

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Portfolio, including fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager, and charged to the Portfolio on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Portfolio pays CAMI an annual management fee to cover the costs of managing the Portfolio. Management fees are based on the Portfolio's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Portfolio. The Portfolio is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units. No management fees or incentive fees are payable by the Portfolio that, to a reasonable person, would duplicate a fee payable by an Underlying Fund for the same service.





Class A Units



Class T4 Units




Class T6 Units





Elite Class Units





Class F Units




