Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance Canadian Core Value Fund (the *Fund*) seeks to achieve long-term investment returns through capital growth by investing in senior issuers that are primarily medium to large Canadian companies.

Investment Strategies: The Fund invests in companies with a track record of earnings, which typically have a market capitalization of more than \$3 billion. The Fund uses a bottom-up, value-oriented approach that attempts to hold a portfolio that is well-diversified among different sectors of the S&P/TSX Composite Index.

Risk

The Fund is a Canadian focused equity fund that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended August 31, 2020, the Fund's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended August 31, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 29% during the period, from \$87,019 as at August 31, 2019 to \$61,355 as at August 31, 2020. Net redemptions of \$22,243 and negative investment performance resulted in an overall decrease in net asset value.

Class A units of the Fund posted a return of -4.4% for the period. The Fund's benchmark, the S&P/TSX Composite Index (the *primary benchmark*), returned 3.8% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

During the period, the COVID-19 pandemic forced many countries to shut down their economies. This led to a sharp and widespread decline in markets as most asset classes were negatively affected by investors seeking to reduce risk. Gross domestic product figures in the first quarter of 2020 were the weakest since 2008–2009, and second-quarter results were even worse, pointing to the severe impact of the pandemic. As lockdowns were enacted, millions of jobs were lost in many countries, including Canada and the U.S., leading to sharply higher unemployment rates.

Central banks and governments around the world announced broad measures to help ensure that financial markets would continue to function properly amid COVID-19, and to limit the economic impact brought about by the disruptions. For instance, the Bank of Canada (the *BoC*) lowered its benchmark overnight interest rate three times, by 50 basis points (*bps*) each time, to 0.25%. The BoC also implemented a bond-buying program to support the economy. This program included purchases of bankers' acceptances, which helped stabilize that market.

Similarly, the U.S. Federal Reserve Board (the Fed) reduced its federal funds rate by 50 bps and 100 bps at two meetings in March, lowering the Fed's target range to 0.00%-0.25%. The Fed noted it expects to maintain this low interest rate through 2021. The Fed also initiated a spending program to support credit conditions for both households and businesses, as well as to maintain the proper functioning of financial markets. The Fed's commitment to supporting economic stability supported financial market strength despite the significant challenges caused by COVID-19.

Supported by those fiscal and monetary measures, markets rebounded substantially from the low levels reached in late March. The gradual reopening of the economy proceeded with a limited and controlled second wave of the virus. Any signs of a renewed outbreak were typically managed with localized lockdowns or shut down of certain activities that may have contributed to viral spread. Research for treatments and vaccines continued to show progress, helping to support investor optimism. Stock selection and a moderate overweight allocation to the financials sector detracted from the Fund's performance, as did stock selection and a slight underweight allocation to the materials sector. A moderate underweight allocation to the information technology sector also detracted.

Individual detractors included an underweight holding in Shopify Inc., which benefited from a strong acceleration of its business model as a result of the pandemic. Overweight holdings in Boardwalk REIT and Fairfax Financial Holdings Ltd. also detracted from performance. Boardwalk struggled primarily as a result of the sharp pandemic-driven decline in oil prices, while Fairfax Financial faced a broad decline in value investments.

A moderate overweight allocation to the health care sector and a moderate underweight allocation to the utilities sector contributed to the Fund's performance, both driven by stock selection. Stock selection and slight overweight exposure to the consumer discretionary sector also contributed to performance.

Individual contributors to the Fund's performance included Microsoft Corp., driven by increased demand for its products as a result of the pandemic, Newmont Corp., as the price of gold appreciated sharply, and Agnico Eagle Mines Ltd., driven by the significant rise in gold prices.

New holdings added to the Fund included European Residential Real Estate Investment Trust, based on the substantial growth potential for apartment properties in the Netherlands. Chinese vehicle and renewable energy equipment manufacturer BYD Co. Ltd. was purchased as a result of the improving outlook for miles driven and potential for consolidation within the industry. Bank of America Corp. was added given the bank's strong capital, attractive valuation and leadership position in digital banking.

Existing Fund holdings that were increased included Constellation Software Inc. based on its attractive and resilient business model. Restaurant Brands International Inc. was increased given the stock's recent decline and the company's attractive business model and growth prospects. Convenience store operator Alimentation Couche-Tard Inc. was increased for its reasonable valuation and strong growth outlook.

Eliminated holdings included MEG Energy Corp. amid concerns related to lower energy prices and the company's balance sheet. ARC Resources Ltd. was eliminated given an unexpected management change, while West Fraser Timber Co. Ltd. was sold to fund other investment opportunities.

Fund holdings that were decreased included Bank of Nova Scotia, as the Portfolio Advisor used proceeds from the partial sale to fund other investment opportunities. TransAlta Corp. was reduced given its strong share price appreciation.

Recent Developments

The composition of the Independent Review Committee (*IRC*) changed during the period. Don Hunter and Merle Kriss retired effective April 26, 2020. Effective April 27, 2020, David Forster and

Deborah Leckman were appointed as members of the IRC. Marcia Lewis Brown was appointed Chair effective April 1, 2020.

The international spread of COVID-19 caused a significant slowdown in the global economy and volatility in financial markets. The COVID-19 outbreak may adversely affect global markets and the performance of the Fund.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

CAMI generally delegates trading and execution authority to the portfolio sub-advisors and does not, in its capacity as portfolio advisor, receive any goods or services directly through soft dollar arrangements.

The Portfolio Advisor and any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor and any portfolio sub-advisors to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a

security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor and any portfolio sub-advisors when they process trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor and any portfolio sub-advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$9,589 to CIBC WM; the Fund did not pay any brokerage commissions or other fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a *Related Dealer*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity and debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;

- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended August 31, 2020. These amounts do not include waived fees or absorbed expenses.






Class A Units
