

# **Annual Management Report of Fund Performance**

for the financial year ended August 31, 2020

All figures are reported in Canadian dollars unless otherwise noted.

### **Management Discussion of Fund Performance**

#### **Investment Objective and Strategies**

Investment Objective: Renaissance Flexible Yield Fund (the *Fund*) seeks to generate long-term total return and current income by investing primarily in high yielding debt and investment grade fixed income securities of issuers located anywhere in the world.

Investment Strategies: The Fund employs a total return approach to buying debt securities with higher yields, and uses a top-down and relative value process to allocate across country, currency, and sector allocations, as well as active management in interest rate decisions. The portfolio sub-advisor can be highly tactical in these allocations. The Fund seeks diversified sources of yield across the debt securities spectrum, and may invest in short-term debt securities when the portfolio sub-advisor is unable to find enough attractive long-term investments.

#### Risk

The Fund is a high yield fixed income fund that is suitable for medium to long-term investors who can tolerate low to medium (Class A, Class F, and Class O units) or low (Class H, Class FH, and Class OH units) investment risk.

For the period ended August 31, 2020, the Fund's overall level of risk remains as discussed in the simplified prospectus.

#### **Results of Operations**

The Fund's portfolio sub-advisor is DoubleLine Capital LP (the *sub-advisor*). The commentary that follows provides a summary of the results of operations for the period ended August 31, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 22% during the period, from \$1,631,556 as at August 31, 2019 to \$1,268,767 as at August 31, 2020. Net redemptions of \$311,558 and negative investment performance resulted in an overall decrease in net asset value.

Class A units of the Fund posted a return of -2.0% for the period. The Fund's benchmarks are the Bloomberg Barclays U.S. Aggregate Bond Index and the LIBOR USD 3 Month (the *benchmarks*), which returned 4.4% and -0.8%, respectively, for the same period. The Fund's return

is after the deduction of fees and expenses, unlike the benchmarks' return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

At the beginning of the period, many economic indicators reached record-high levels. Toward the end of the first quarter of 2020, however, the COVID-19 virus began to spread across the U.S. This prompted the U.S. government to enact lockdowns and business shutdowns to help contain the spread, bringing economic activity to a virtual halt. In response, the U.S. economy shrank considerably, entering a recession during the second quarter of 2020.

March 2020 was one of the most volatile months in modern financial history for both equity and fixed income markets. Both markets declined sharply as uncertainty around the impact of COVID-19 remained high.

As a result, markets significantly declined over the first quarter of 2020 as the pandemic continued to create heightened global economic uncertainty. Both equity and fixed income markets declined sharply as efforts to contain the virus disrupted economic activity and led to high unemployment. These markets recovered somewhat late in March after the U.S. Federal Reserve Board (the *Fed*) intervened with several aggressive stimulus measures and policymakers implemented a significant economic relief package.

Overall, the Fed's actions to counteract the effects of the pandemic were generally supportive of the corporate bond market, helped to reignite demand across corporate bond sectors and created an environment where owning risk assets was rewarded. These actions included lower interest rates, a significant bond-buying program and allowing interest rates to stay "lower for longer."

Holdings in the travel and hospitality segments of the asset-backed securities and commercial mortgage-backed securities (*CMBS*) markets detracted from the Fund's performance. These two industries were significantly impacted by the pandemic and declined sharply. Bank loans also detracted from the Fund's performance as bank loan fund outflows continued to break records in an environment of

extremely low interest rates. Also, relative to the high-yield bond market, the bank loan market has higher exposure to the retail and leisure industries, both of which struggled as a result of COVID-19.

In the first half of the period, emerging markets significantly outperformed every other region as many developing countries were experiencing economic growth. The Fund had overweight exposure to emerging markets during that time. As the pandemic left many developing countries struggling to contain the spread of COVID-19, the sub-advisor reduced the Fund's emerging markets exposure to an underweight allocation and rotated into higher-quality assets. This combination of an overweight allocation to emerging markets when they outperformed and an underweight allocation when they underperformed contributed to the Fund's performance.

Increased holdings included non-agency residential mortgage-backed securities as the Fund's target allocation rose to increase exposure to structured products. Also to increase exposure to structured products, the Fund's target allocations to collateralized loan obligations and CMBS were increased. To increase the Fund's exposure to higher-yielding assets, the target allocations to high-yield securities and bank loans were each increased.

The Fund's target allocation to U.S. government issues was decreased, given that U.S. treasury bill yields declined significantly. The Fund's target allocation to emerging markets was also lowered as developing countries continued to struggle to contain the spread of COVID-19.

# **Recent Developments**

Effective June 16, 2020, the annual management fee payable was reduced from 1.50% to 1.45% in respect of Class A units, from 1.50% to 1.45% in respect of Class H units, from 0.75% to 0.70% in respect of Class F units, and from 0.75% to 0.70% in respect of Class FH units.

The composition of the Independent Review Committee (*IRC*) changed during the period. Don Hunter and Merle Kriss retired effective April 26, 2020. Effective April 27, 2020, David Forster and Deborah Leckman were appointed as members of the IRC. Marcia Lewis Brown was appointed Chair effective April 1, 2020.

The international spread of COVID-19 caused a significant slowdown in the global economy and volatility in financial markets. The COVID-19 outbreak may adversely affect global markets and the performance of the Fund.

#### **Related Party Transactions**

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As

Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

#### Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (CIBC ISI), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (CIBC WM). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

CAMI generally delegates trading and execution authority to the portfolio sub-advisors and does not, in its capacity as portfolio advisor, receive any goods or services directly through soft dollar arrangements.

The Portfolio Advisor and any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor and any portfolio sub-advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor and any portfolio sub-advisors when they process trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor and any portfolio sub-advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

#### **Fund Transactions**

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity and debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

#### Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio

transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

#### Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

#### **Management Fees**

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisor are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O and Class OH units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such management fee for Class O and Class OH units will not exceed the annual management fee rate for Class F and Class FH units respectively.







# Class H Units





# Premium Class Units





# Class H-Premium Units









# Class F-Premium Units






