Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance Global Focus Fund (the *Fund*) seeks to achieve long-term capital growth by investing primarily in equity securities of companies throughout the world in the sector categories determined by the portfolio sub-advisor.

Investment Strategies: The Fund seeks to invest primarily in companies in which stock price movements follow improvement in the rate of change in growth of earnings and revenues, rather than absolute growth. In addition, the Fund seeks to identify global companies with earnings, revenues, and operating income that are growing at an accelerating pace.

Risk

The Fund is a global equity fund that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended August 31, 2020, the Fund's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio sub-advisor is American Century Investment Management, Inc. (the *sub-advisor*). The commentary that follows provides a summary of the results of operations for the period ended August 31, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 39% during the period, from \$53,013 as at August 31, 2019 to \$73,848 as at August 31, 2020. Net sales of \$11,502 and positive investment performance resulted in an overall increase in net asset value.

Class A units of the Fund posted a return of 15.8% for the period. The Fund's benchmark, the MSCI World Index (the *benchmark*), returned 15.1% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

The COVID-19 pandemic had a significant negative impact on equity markets in the first quarter of 2020, as global supply chains were disrupted and lockdowns slowed global demand. However, stocks rebounded sharply in the second quarter despite continued uncertainty surrounding the pandemic. Record amounts of fiscal and monetary stimulus globally, including Europe's additional €750 billion plan, helped support stocks.

Second-quarter corporate earnings reports were not as weak as originally anticipated by the market. Although growth continued to decline, earnings results generally showed that the low estimates made in the first quarter were overly pessimistic.

Toward the end of the period, optimism about a slowdown in the spread of COVID-19 and progress achieved by multiple companies regarding a potential vaccine supported further equity market gains. Ongoing monetary and fiscal stimulus by central banks and governments worldwide continued to provide significant support for economic growth.

Stock selection in and the resulting significant overweight allocation to the information technology sector contributed to the Fund's performance. Payment processor Adyen NV and e-commerce services provider Shopify Inc. benefited from accelerating trends toward e-commerce. Data centre operator GDS Holdings Ltd. benefited from positive cloud computing trends, and factory automation specialist Keyence Corp. benefited from the trend toward onshoring of manufacturing. Stock selection and a significant underweight allocation to the underperforming financials sector also contributed to performance.

Individual contributors to the Fund's performance included online apparel retailer ASOS PLC, which benefited from strong results driven by higher demand, higher revenue and increased profitability. Cellnex Telecom SA contributed on strong results and robust customer activity. Adyen also contributed amid an accelerated shift from cash to card payments, as well as a rise in online spending.

Stock selection in the consumer staples sector detracted from the Fund's performance. Individual detractors from performance included Melrose Industries PLC. The stock declined amid substantial weakness in the automotive and aerospace markets. The company faced potential liquidity concerns and end-market demand pressures that reduced prospects for near-term earnings growth. Treasury Wine Estates Ltd. detracted as inventory overruns and strong price pressure caused the company to miss earnings expectations and issue a profit warning. Burberry Group PLC also detracted from performance as a result of concerns about a pandemic-related decline in demand and the firm's high exposure to the office-wear market.

New holdings added to the Fund included Murata Manufacturing Co. Ltd. as the supplier of components used in cellular handsets and base stations experienced an increase in demand driven by the rollout of 5G technology. The sub-advisor believes that the company may experience growth in 5G handsets (relative to 4G) of roughly 30% to 40%.

Valeo SA was purchased as a stock price decline provided an opportunity to invest in what the sub-advisor believes is a company well positioned to benefit from structural changes in the automotive industry. For instance, "green" initiatives are driving the shift toward electric vehicles, hybrids and stricter emissions standards. Novo Nordisk AS was purchased as the sub-advisor believes the pharmaceutical firm may benefit from a sharp improvement in revenue and earnings growth based on the approval of its new diabetes drug, Rybelsus.

Eliminated Fund holdings included Danone SA, which the sub-advisor sold in anticipation that the company's growth rate would decrease heading into the fourth quarter of 2019. The sub-advisor was concerned about the company's quarterly results, which showed that Danone was struggling to grow volumes. InterXion Holding N.V., a data centre operator based in the Netherlands, received a takeover bid from Digital Realty Trust Inc., a U.S. data centre real estate investment trust. The takeover announcement increased the stock price to a valuation level that the sub-advisor believed was unsustainable, and the holding was exited. The Fund's holding in Diageo PLC was sold as the sub-advisor believed there was limited room for further growth.

Recent Developments

The composition of the Independent Review Committee (*IRC*) changed during the period. Don Hunter and Merle Kriss retired effective April 26, 2020. Effective April 27, 2020, David Forster and Deborah Leckman were appointed as members of the IRC. Marcia Lewis Brown was appointed Chair effective April 1, 2020.

The international spread of COVID-19 caused a significant slowdown in the global economy and volatility in financial markets. The COVID-19 outbreak may adversely affect global markets and the performance of the Fund.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (CIBC ISI), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (CIBC WM). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

CAMI generally delegates trading and execution authority to the portfolio sub-advisors and does not, in its capacity as portfolio advisor, receive any goods or services directly through soft dollar arrangements.

Portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by portfolio sub-advisors, including ACI, to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to portfolio sub-advisors, including ACI, that process trades through them

(referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of brokerage commissions and assist portfolio sub-advisors with investment decision making services to the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

CAMI may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity and debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with

conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing foreign exchange transactions. The fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Prior year fees attributable to exchange traded funds have been reclassified to the management expense ratio and management expense ratio before waivers or absorptions.

The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisor are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended August 31, 2020. These amounts do not include waived fees or absorbed expenses.




Year-by-Year Returns






Class F Units
