Management Discussion of Fund Performance

Results of Operations

Renaissance Canadian Core Value Fund (the *Fund*) invests in a combination of direct investments in other mutual funds (individually, an *Underlying Fund*, and collectively, the *Underlying Funds*) which can be found in the Top Positions table of the Summary of Investment Portfolio. The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*).

The Fund's net asset value decreased by 12% during the period, from \$87,019 as at August 31, 2019 to \$76,159 as at February 29, 2020. Net redemptions of \$11,820 were partially offset by slightly positive investment performance, resulting in an overall decrease in net asset value.

Class A units of the Fund posted a return of 0.2% for the period. The Fund's benchmark, the S&P/TSX Composite Index (the *benchmark*), returned 0.4% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See *Past Performance* for the returns of other classes of units offered by the Fund.

During the period, the Bank of Canada (the *BoC*) held its target overnight interest rate steady at 1.75%, citing a robust labour market and strong inflation. However, the BoC was more cautious toward the end of the period as Canadian economic growth slowed and potential risks to the economy heightened. Canada's inflation rate held firm at close to the BoC's 2% target, partly as a result of rising food prices. The Canadian labour market was robust. The economy added jobs, while the unemployment rate remained close to 40-year lows. Canadian economic growth weakened and business investment and exports both declined. Overall, the Canadian economy was impacted by strikes (automotive and rail) and pipeline shutdowns.

The U.S. and China agreed on a "phase one" trade deal. While outstanding issues still remained unresolved, both countries have incentives to put their differences aside for the foreseeable future. The U.K. came to an agreement with the European Union about its exit.

Fears of the economic impact of the COVID-19 outbreak in China, which spread to other parts of the globe, weighed on investor

confidence in the final weeks of February. Uncertainty over its impact drove risk premiums higher in late February, leading to a broad-based global stock market decline.

A significant underweight allocation to the industrials sector detracted from the Fund's performance. A slight overweight exposure to the materials sector and moderate overweight allocation to the financials sector also detracted from the Fund's performance.

Individual detractors from the Fund's performance included holdings in Westshore Terminals Investment Corp. and Kirkland Lake Gold Ltd., as well as a significant underweight allocation to Shopify Inc. Shopify performed well, continuing to deliver on growth. Westshore Terminals Investment's shares declined amid concerns related to contract negotiations with its largest customer. Kirkland Lake Gold was affected by concerns related to mergers and acquisitions and a reserve update.

Security selection was the primary contributor to the Fund's performance during the period. A slight underweight allocation to the energy sector contributed to the Fund's performance, as did a moderate overweight exposure to the health care sector and slight overweight exposure to the consumer discretionary sector.

Individual contributors to the Fund's performance included TransAlta Corp., Enbridge Inc. and Microsoft Corp. TransAlta benefited from its plan for decarbonization and strength in renewables. Enbridge's stock price rose as a result of lower interest rates and progress on its Line 3 replacement. Microsoft reported strong earnings growth and the expansion of its cloud computing business.

The Portfolio Advisor added a number of new holdings to the Fund during the period. European Residential REIT was added in September 2019 based on the substantial growth potential for apartment properties in the Netherlands. Restaurant Brands International Inc. was purchased in October 2019 given the attractive entry point into a high-quality business. Canadian National Railway Co. was added in February 2020 for its reasonable valuation and the potential for recovery in rail volumes. An existing holding in Canadian

Western Bank was increased for its attractive valuation and potential for capital return.

MEG Energy Corp. was eliminated from the Fund amid concerns related to lower energy prices and the company's balance sheet. BlackBerry Ltd. was sold based on the Portfolio Advisor's concerns related to execution and competition. Ovintiv Inc. (formerly Encana Corp.) was sold after it announced it would re-domicile to the U.S. A holding in Jamieson Wellness Inc. was eliminated after a period of strong share price performance. ARC Resources Ltd. was sold given the company's unexpected management change. The Fund's holding in Chemtrade Logistics Income Fund was eliminated amid concerns of high debt levels.

The Portfolio Advisor reduced the Fund's holding in Bank of Nova Scotia in order to fund other investment opportunities. TransAlta was trimmed after a period of strong share price performance.

Recent Developments

The composition of the Independent Review Committee (*IRC*) changed. Don Hunter and Merle Kriss retired effective April 26, 2020. David Forster and Deborah Leckman were appointed as members of the IRC effective April 27, 2020.

The outbreak of COVID-19 (the disease caused by a new coronavirus) in China in December 2019, and its subsequent spread and designation as a global pandemic, has caused a slowdown in global economic activity and sustained market volatility. This has impacted global markets, with the most significant valuation changes occurring since the end of the review period. This has affected, or could affect, the performance of the Fund in an adverse manner.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc.

(CIBC WM). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

CAMI generally delegates trading and execution authority to the portfolio sub-advisors and does not, in its capacity as portfolio advisor, receive any goods or services directly through soft dollar arrangements.

The Portfolio Advisor and any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor and any portfolio sub-advisors to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor and any portfolio sub-advisors when they process trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor and any portfolio sub-advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$4,243 to CIBC WM; the Fund did not pay any brokerage commissions or other fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to the Portfolio Advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity and debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid

by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

⁷ The trading expense ratio represents total commissions and other portfolio transaction costs before income taxes expressed as an annualized percentage of the daily average net asset value during the period. Spreads associated with fixed income securities trading are not ascertainable and, for that reason, are not included in the trading expense ratio calculation.

The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.





Class A Units




Class F Units
