Management Discussion of Fund Performance

Results of Operations

Renaissance Global Science & Technology Fund's (the *Fund*) portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the six-month period ended February 29, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 20% during the period, from \$70,846 as at August 31, 2019 to \$84,897 as at February 29, 2020. Net sales of \$6,627 and positive investment performance resulted in an overall increase in net asset value.

Class A units of the Fund posted a return of 11.0% for the period. The Fund's primary benchmarks are the MSCI World Information Technology Index and the MSCI World Index (the *benchmarks*), which returned 12.2% and 2.1%, respectively, for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See *Past Performance* for the returns of other classes of units offered by the Fund.

A resumption of monetary stimulus, economic resilience in the U.S. and the lack of a recession helped to restore investor confidence over most of the six-month period. Global equities had a relatively positive period until the end, when investor concern regarding COVID-19 increased. Adding to the initially positive equity market environment was the de-escalation of the China-U.S. trade dispute. Indicative of this more optimistic outlook, growth-related stocks, including in the information technology sector, were favoured by investors. However, while the U.S. retained its economic strength, the global backdrop remained uncertain. Weakness in manufacturing activity raised concerns that the relative buoyancy in private consumption would not be sustained if employment and wage trends weakened. Furthermore, valuations rose against the backdrop of tepid earnings growth. Investor optimism eventually gave way to concerns relating to the spread of the COVID-19 virus. There was increasing acknowledgment that the global economic outlook was being impacted by the outbreak. Science and technology companies suffered from the same broad equity market sell off that impacted equities across the globe.

A significant underweight allocation to Apple Inc. detracted from performance as the market started pricing in 5G phone growth, expected in 2020. Significant underweight holdings in IAC/InterActiveCorp and CVS Health Corp. also detracted from the Fund's performance. IAC/InterActiveCorp's stock price declined as Match Group Inc., in which the company owns controlling shares, struggled with near-term issues from decelerating revenue growth and margins. CVS Health was negatively affected by concerns about the upcoming U.S. presidential election.

Security selection contributed to the Fund's performance. A slight overweight allocation to the consumer discretionary sector and slight underweight exposure to the communication services sector also contributed to performance.

Individual contributors to the Fund's performance included NVIDIA Corp., Seattle Genetics Inc. and Splunk Inc. NVIDIA benefited from rapid growth in its data centre business, while Seattle Genetics reported positive pipeline readouts. Splunk's positive earnings report lessened investor concerns over financial results.

The Portfolio Advisor introduced a number of new holdings to the Fund during the period. Lam Research Corp. was added amid a significant increase in memory capital expenditures as a result of the rise in memory requirements for 5G and natural language processing. BioMarin Pharmaceutical Inc. was purchased for its specialty in orphan conditions. Avalara Inc. was added to the Fund as the company benefits from the rise of ecommerce and allowing the calculation, collection and filing of taxes for retailers.

Existing holdings in Activision Blizzard Inc., MasterCard Inc. and Apple Inc. were increased. The Portfolio Advisor took advantage of equity market volatility to increase the Fund's holding in Activision Blizzard, which should benefit from higher revenues in 2020. The Portfolio Advisor also took advantage of volatility and issues around

COVID-19 to increase the Fund's holding in MasterCard. Apple was increased based on 5G phone catalysts for 2020.

The Fund's holding in Adobe Systems Inc. was eliminated to fund new investments. Deciphera Pharmaceuticals Inc. was sold following strong performance. The company reported robust data in its pivotal phase 3 clinical trial of DCC-2618. Sony Corp. was trimmed to take profits from a holding that has performed well since its introduction into the Fund. The holding in NVIDIA was reduced to take profits to fund new investments.

Recent Developments

The composition of the Independent Review Committee (*IRC*) changed. Don Hunter and Merle Kriss retired effective April 26, 2020. David Forster and Deborah Leckman were appointed as members of the IRC effective April 27, 2020.

The outbreak of COVID-19 (the disease caused by a new coronavirus) in China in December 2019, and its subsequent spread and designation as a global pandemic, has caused a slowdown in global economic activity and sustained market volatility. This has impacted global markets, with the most significant valuation changes occurring since the end of the review period. This has affected, or could affect, the performance of the Fund in an adverse manner.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (CIBC ISI), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (CIBC WM). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales

commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, when CAMI processes trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of brokerage commissions and assist CAMI with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$4,448 to CIBC WM; the Fund did not pay any brokerage commissions and fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to the Portfolio Advisor:
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of

the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);

- purchase equity and debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (CIBC GSS) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended February 29, 2020. These amounts do not include waived fees or absorbed expenses.





Class A Units




