Management Discussion of Fund Performance

Results of Operations

Renaissance Optimal Growth & Income Portfolio (the *Fund*) invests in a combination of direct investments in other mutual funds (individually, an *Underlying Fund*, and collectively, the *Underlying Funds*) which can be found in the Top Positions table of the Summary of Investment Portfolio. The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*).

The commentary that follows provides a summary of the results of operations for the six-month period ended February 29, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 5% during the period, from \$473,266 as at August 31, 2019 to \$450,768 as at February 29, 2020. Net redemptions of \$25,512 were partially offset by slightly positive investment performance, resulting in an overall decrease in net asset value.

Class A units of the Fund posted a return of 0.6% for the period. The Fund's primary benchmarks, the FTSE Canada Universe Bond Index and the S&P/TSX Composite Dividend Index (the *benchmarks*), returned 1.9% and 0.9%, respectively, for the same period. The Fund's blended benchmark (the *blended benchmark*) comprises 40% FTSE Canada Universe Bond Index, 30% S&P/TSX Composite Dividend Index and 30% MSCI World Index. The blended benchmark returned 1.8% for the same period. The blended benchmark closely reflects the asset classes in which the Fund invests, and is designed to provide a more useful comparative to the Fund's performance. The Fund's return is after the deduction of fees and expenses, unlike the benchmarks' returns. See *Past Performance* for the returns of other classes of units offered by the Fund.

Across global financial markets, recession concerns had begun to recede late in 2019 as economic growth improved and investors anticipated a reduction in trade frictions between the U.S. and China. However, global recession concerns resurfaced in the final weeks of February 2020 as the spread of COVID-19 disrupted supply chains between China and the rest of the world. In the Canadian equity market, the resumption of economic growth was beginning to take hold until COVID-19 began to dominate headlines and investor concerns. Commodities, including oil, copper and iron ore, had a strong start to the period before reversing course amid demand concerns. The price of gold was strong, initially as a result of strong demand and a weaker U.S. dollar. Later, amid investor risk aversion and a "flight to safety," gold prices remained strong.

Similarly, during the last four months of 2019, U.S. stocks were supported by easing recession concerns, resilient economic growth and more accommodative monetary policy. Positive trade policy news also provided support to equities toward the end of 2019. Broad U.S. market indices declined sharply toward the end of February, however, as concerns of the widening COVID-19 outbreak weighed on investor confidence and weakened economic forecasts.

Globally, the infrastructure sub-sector has less sensitivity to economic growth than broader equity markets, and is generally supported by lower bond yields. As a result, infrastructure assets performed well relative to global equities during the period. The U.K. general election result in December 2019 provided greater certainty around the U.K.'s exit from the European Union, and supported U.K. assets. It also removed the risk of nationalization of U.K. regulated assets and is expected to result in greater fiscal stimulus.

In fixed income markets, the Bank of Canada (the *BoC*) held its target overnight interest rate steady at 1.75%, based on a robust labour market and strong inflation. However, the BoC became more cautious toward the end of the period as Canadian economic growth slowed and potential risks to the economy heightened. Canada's inflation rate held firm at close to the BoC's 2% target, partly as a result of rising food prices. The Canadian labour market was robust. The economy added jobs, while the unemployment rate remained close to 40-year lows. Canadian economic growth weakened, and business investment and exports both declined, as the Canadian economy was impacted by strikes and pipeline shutdowns.

Canadian fixed income assets posted positive returns, with higher-risk assets generally outperforming. Canadian federal bonds

underperformed Canadian provincial bonds, and both underperformed Canadian corporate bonds.

Globally, fixed income markets reacted strongly to the spread of COVID-19 and its potential disruption to economic growth, sending bond yields lower and credit spreads (the difference in yield between government and corporate bonds of similar maturity) wider.

Higher-quality global developed market bonds and other "safe haven" assets rebounded amid the uncertainty. Many emerging markets bond markets and currencies, given their close links to Chinese economic growth and export demand, declined through February. Several central banks stepped in with pre-emptive actions against potential COVID-19 fallout.

The London interbank offered rate (*LIBOR*) declined significantly amid negative sentiment and global central bank actions.

Renaissance High-Yield Bond Fund was the most significant detractor from the Fund's performance relative to the blended benchmark, followed by Renaissance U.S. Equity Income Fund and Renaissance Global Bond Fund.

Renaissance Canadian Dividend Fund was the most significant contributor to the Fund's performance relative to the blended benchmark, followed by Renaissance Global Infrastructure Fund and Renaissance Canadian Bond Fund.

Recent Developments

The composition of the Independent Review Committee (*IRC*) changed. Don Hunter and Merle Kriss retired effective April 26, 2020. David Forster and Deborah Leckman were appointed as members of the IRC effective April 27, 2020.

The outbreak of COVID-19 (the disease caused by a new coronavirus) in China in December 2019, and its subsequent spread and designation as a global pandemic, has caused a slowdown in global economic activity and sustained market volatility. This has impacted global markets, with the most significant valuation changes occurring since the end of the review period. This has affected, or could affect, the performance of the Fund in an adverse manner.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, when CAMI processes trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of brokerage commissions and assist CAMI with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into the following transaction (the *Related Party Transaction*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to the Portfolio Advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity and debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid

by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.









Class T4 Units


Class T6 Units







Select Class Units



Select-T4 Class Units




Select-T6 Class Units





Elite Class Units



Elite-T6 Class Units




Elite-T8 Class Units





Class F Units






Class FT6 Units
